**Key Requirements:** Qualified manager with 2+ years experience, BSIS training, \$1M liability insurance

### Texas - Security Services Contractor

**Agency:** Texas Department of Public Safety

**Fee:** \$700

**Training:** 30 hours (Level II), 15 hours additional (Level III armed)

**Processing:** 8-12 weeks

**Key Requirements:** Qualified manager, \$10,000 surety bond, \$100,000 liability insurance

### Florida - Class B Security Agency

**Agency:** Florida Department of Agriculture, Division of Licensing

**Fee:** \$600

**Training:** 40 hours (Class D), additional 28 hours (Class G armed)

**Processing:** 8-10 weeks

### New York - Security Guard Company License

**Agency:** NY Department of State, Division of Licensing Services

**Fee:** \$900

**Training:** 47 hours pre-assignment + 8 hours annual in-service

**Processing:** 10-14 weeks
